## **FLAT RATE ANNUAL INSPECTION**

Guardian Aerospace is now offering “Flat Rate Annual Inspections” for general operating aircraft in accordance with CARs 625.86 Appendix B. Items included in the inspection are

- Log book and Technical Records (1 hour)
- AD compliance check (1 Hour)
- Removal and installation of inspection panels or fairing required for inspection.
- Run up and systems check (pre/post inspection)
- Spark plug cleaning and inspection
- Compression test
- Battery inspection and servicing
- Oil and oil filter change\*
- Air filter and/or hydraulic filter replacement\*
- Lubrication of controls and control systems
- Lubrication of grease fittings
- Magneto Timing check
- Compass swing, Tachometer Check

**\*Labour only**

Upon completion of the inspection the customer will be notified of any findings and the corrective action recommended. Findings that do not affect the airworthiness of the aircraft and are not rectified will be noted in the maintenance release.

Prices do not include parts, supplies or consumables that may be used during the inspection including but not limited to; hardware, replacement parts, oil, grease, or solvents. AD research or compliance action requiring more than the initial 1 hour will be billed at normal shop rate.

An initial review of the A/C Log book and technical records is required for all aircraft. During this review we assess the age and condition of the A/C and its components. Complete records, legible and detailed entries reduce maintenance costs in the long run. Additional costs may be incurred where exhaustive research is required; Owners may assist in the initial review and should contact us for instructions.

CARs 625.86 Appendix C may require additional maintenance or inspections be carried out. These items are described as “out of phase tasks” and include but are not limited to.

- ELT Recertification/ battery replacement
- Propeller OH or Corrosion inspection
- Transponder and Altimetry equipment inspection/calibration
- First aid, emergency and survival equipment

When Quoting a Flat Rate inspection we consider the average hours required to complete all inspection tasks pertaining to Appendix B. If your aircraft is not listed below please contact us for a personal quote and be sure to include your specific aircraft information. All quotes assume that the aircraft is on wheels and will be made available at CAU4 for inspection.
